

# Empowering Students to Imagine ~ Believe ~ Achieve 2010 Counselor Academy

The 2010 Academy was an exciting and informative experience with 247 school counselors' signed up to participate. The Academy started off with the Keynote talk of Dr. Trish Hatch. As many of you probably remember, she came to Nebraska several times for the original Counselor Academy's sponsored by Donna Vrbka to talk about the ASCA Model so it was nice to have her back in the area.

Current ASCA President Brian Law gave an inspirational talk on Friday morning reminding us that we need to talk about what we do. All of our stories are important even if we don't think it is big enough to talk about; just like the "bead lady" we make a difference.

Karen Harrington from the Center for School Counseling Outcome Research – University of Massachusetts Amherst gave us valuable information that was collected in our state. Utah, Missouri Connecticut, Rhode Island and Nebraska took part in this study. School counseling programs make a difference. These programs affect positive student outcomes such as higher graduation rates, higher attendance rates, higher math and reading proficiency, lower suspension and lower discipline rates, and improved technical career skills. You will be hearing a lot more about this study.

There were 48 breakout sessions for counselors to attend and from the look of the evaluations, it appears valuable information was gained. New this year was an evening reception in order for counselors to have a relaxed atmosphere to visit and network. We want to thank Metro Community College for this opportunity.

At the general meeting, annual elections were held. Results are found in this newsletter. Dawn Smith, By-Laws committee chair, presented a change of wording to Article III, Section 2. All NSCA members should have received a ballot on this in mid-November. Also, a discussion was held about the recent NCA by-law change.

The Friday luncheon was wonderful. Governor Heineman joined us for lunch and spoke about his P-16 Initiative. He was extremely complimentary of school counselors and teachers and the work we do. He would love to hear from school counselors about any concerns we have. This year we awarded four awards: Outstanding Elementary Counselor – Mary Achelpohl; Outstanding Middle School Counselor – Mary Lincoln; Outstanding Senior High School Counselor – Mary Janata; and Outstanding Supporting Administrator Award – Ken Theile. The luncheon concluded with a drawing for over 30 prizes.

I sincerely thank those counselors that were able to attend this year's Academy. I hope that you left with numerous ideas to continue to empower students to imagine, believe, and achieve. Plans are under way for the 2011 Academy and we hope you return for another fabulous and educational experience.

## Rights for Noncustodial Parents

Can you call a noncustodial parent about a social-emotional issue involving his or her child? Can a non-custodial parent have the right to be included in parentteacher conferences and to receive records? ls education the school obligated to notify the custodial parent contacting before the noncustodial parent?

"Custodial parent" is a term used for the parent who has primary physical custody of a child. Typically the child resides with the custodial parent. "Noncustodial parent" is used for the parent who has the child for a lesser amount of time. Typically the child does doesn't reside with the noncustodial parent except during the time the noncustodial parent exercises his/her visitation rights with the child.

Unless there is a court order expressly stating otherwise, noncustodial parents enjoy all the same rights as custodial parents. Noncustodial parents can participate in parent-teacher conferences, receive report cards and progress reports and get copies of educational records.

You may contact noncustodial parents and involve them in an academic or emotional issue. In an effort to preserve your relationship with custodial parents, however, you may decide to inform them any time you've called a noncustodial parent. This is a judgment call that would depend on the context, history and the student who is experiencing the problem.

## C.I.A academy at Broken Bow Middle School.

On November 24, we held our very first C.I.A. academy. C.I.A. stands for Character in Action. This is a group in our school that functions much like a student counsel and anti-drug group. I choose to utilize this group for the student leadership team. I found them to be a big help in getting rooms ready and for helping speakers find rooms and needed items. I began the planning of this event in October. In the planning of this, I choice topics that were relevant in our school such as: leadership development, bullying, and dating violence. I also chose to incorporate some career education to make a connection with good decision making and career opportunity. After choosing the date and setting up a schedule I contacted and lined up potential speakers, purposely trying to find as many local experts as possible. I felt this was going to be helpful in keeping expenses down and getting administration on board.

I am blessed by having a great administrator who was on board with the idea right away. I feel that having a solid plan of action in place before I went to the Principal went a long way in getting him on board and exited about the program so quickly. Mr. Kujath even offered to teach a session on leadership that I think was a great benefit to the program and the kids.

The day ran on a shortened bell schedule. I used that schedule to organize my student groups and presenters. We had six groups of thirty with one or two teachers per group to help keep kids organized. To avoid confusion I did not give the students their order of speakers. The teachers took care of this and I feel it worked very well. Each presentation ran for 35 minutes with a five minute break between each session. Our six topics were: Leadership, Dealing with People, Sexting and Cyber-Bullying, What to Expect at Work, Dating Violence, and The Law and Bullying. Here are some things we did that made the event successful:

- 1. Got local people involved right away.
  - This was helpful in promoting the idea to the principal and other members of the staff. It also gave the presenters time to get a great presentation together. All of them went above and beyond expectations.
- 2. Set up a special twist to the day.
  - We had a pizza luncheon built into the day. This included my leadership team and all the speakers. We also had all the students of the week and students of the month as well as staff attend the luncheon. Kids were exited and asked about the event all week long.
- 3. Recognize the presenters.
  - We ended or day with a pep rally at which I presented the speakers with a certificate of appreciation.
- 4. Contact the media.
  - This is our way to let people know about all the great things going on in our school.
- 5. Organization.
  - I got all the planning and prep done ahead of time. By taking care of details ahead of time, the day ran very smoothing, and just as I had intended. I had teachers in charge of groups and I went out of my way to make it as easy as possible for them that day.

The results were amazing. Kids were talking about the day and what they learned. Even the teachers commented on learning from the experience. We even saw a new side to several of our students that we may have not otherwise seen if we had not been in this type of setting.

In all, this type of event took a lot of work, a lot of time, and a lot of planning in order to run smoothly. Despite that, it is well worth the time and will be a huge benefit to any school that puts an event like this on.
